Dear Parents and Guardians,

Registration form and tuition materials are enclosed and posted in Parent Square along with the website. Families registered in Holy Trinity and St. Peter's parishes will receive a scholarship of \$150 per student in K3 thru eighth grade.

All families will need to sign up for a FACTS account to pay tuition, lunch, Angel Care and apply for the Neumann Scholarship: <https://online.factsmgmt.com/signin/3NHVD>

The largest source of financial assistance for our parents is the **Neumann Scholarship**, which is funded by Pennsylvania's Education Income Tax Credit (EITC). The scholarship application link is the same as the tuition accounts: <https://online.factsmgmt.com/signin/3NHVD>.

The deadline for submitting the Neumann Scholarship application is April 15, 2017.

The **School Support Scholarship** is financed with monies earned through the sale of Gift Cards, OLA Scrip Program and Musser's Market Gold cards. Gift Cards for stores, restaurants, convenience stores, gas stations may be purchased at the school office or parish office. Log on to Shop with Scrip to see a complete list of gift cards available.

An application form for the School Support Scholarship is included with this packet. The deadline for this scholarship is May 1, 2017.

Tuition Assistance will not be considered until registration to Our Lady of the Angels School is completed in full and all materials and registration fees have been received.

In order for us to **hold** a place for your child/ren the following must be in place:

1. A completed registration form (separate form for students entering K3-K4 and K5)
2. The registration fee and stationery fee paid.

The discounted 2017-2018 registration fee of \$100 must be received by **3:15pm Tuesday, April 18th**. After April 18th the registration fee increases to \$150 per child.

Books and other supplies are purchased based on the number of students who register. Therefore it is imperative that you register as soon as possible.

A \$35 stationery fee per student is charged for K3 through Grade 8. This fee covers the cost of all supplies (paper, pencils, crayons, etc) for the school year and is paid with the registration fee.

****If you are registering a child for K3, K4, or K5 you are to include their name on the re-registration form. However, you MUST also include a separate registration form for K3, K4, and K5. This form is available on the website.**
